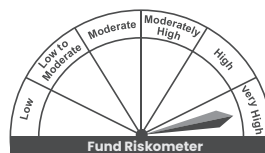

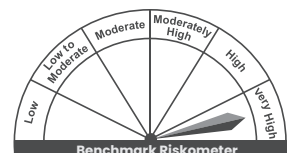

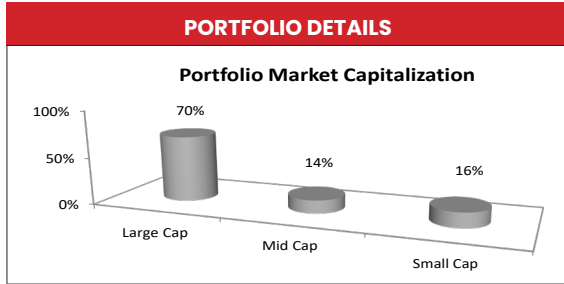
AMFI Tier I Benchmark - Nifty 500 TRI



