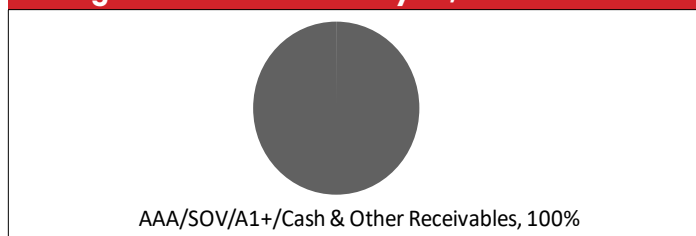




Portfolio as on February 28, 2023

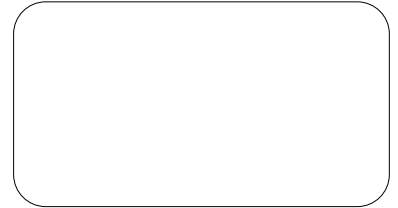
