Works on a quantitative model that selects stocks from S&P BSE 200 universe by considering company performance, its valuation and the price momentum.

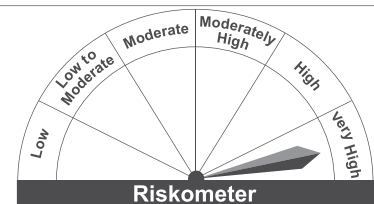

- ▶ It is an actively managed investment fund that approaches stock selection process based on a proprietary system-based model.
- ▶ The model would shortlist 30-35 S&P BSE 200 stocks through a screening mechanism at pre-determined intervals, i.e. on quarterly basis.
- ▶ Stocks are selected on basis of parameters like valuation, earnings, price, momentum & quality.

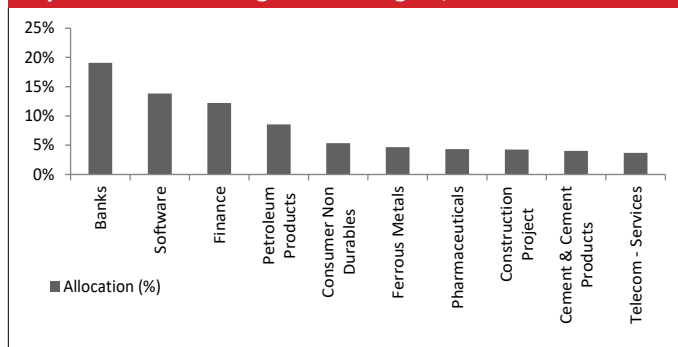
