No negotiations taking place with Tata Consumer Products: Coffee Day

PRESS TRUST OF INDIA New Delhi, September 25

DEBT-RIDDEN Coffee Day Enterprises on Thursday said it continues to explore and evaluate various opportunities amid reports that it is in talks with Tata group firm TCPL to sell its vending machine business.

Coffee Day Enterprises (CDEL), however, in a regulatory filing said there is no such negotiation or events taking place with Tata Consumer Products (TCPL) in this regard.

Meanwhile, TCPL said it evaluates various opportunities on an ongoing basis without confirming or denying



talks with CDEL.

TCPL's reply came over reports that it is in talks with CDEL to acquire the latter's vending machine business. "The company evaluates various opportunities on an ongoing basis. As a policy, we do not comment on speculative information,"TCPL said.

CDEL, on its part, said as part of an ongoing restructuring exercise, any such proposal by any company is always a subject matter of feasibility studies and the need for requisite consents.

"To this end, there are several ongoing discussions. None of these conversations have reached any conclusive stage, and it would be factually incorrect to speculate anything to the contrary," a CDEL spokesperson said.

If any deal is finalised, it would be a breather for CDEL. which is facing pressure to repay debts after its founding chairman VG Siddhartha

passed away last year. Its coffee chain Cafe Coffee

Day (CCD) has closed down around 280 outlets in the first quarter this fiscal, taking the number down to 1,480 as on June 30, 2020, on account of profitability issues and the possibility of future increase in expenses. CCD was operating 1,742 outlets in the April-June quarter last fiscal and 1,752 in the January-March quarter.

CDEL has been paring its debt through the sale of noncore assets after the death of its promoter.
